Dee will also ask her activity coordinators if there is anyone in their groups who might like to become the luncheon chair, to get the word out further.

Jane brought binders of prior years' programs that are a great resource for ideas. Chair yoga, magicians, working with a talent agency. Claudia mentioned calling TV stations to see if a meteorologist might be able to present. Barb Sweet mentioned a choir, not affiliated with a church, that some of our members are part of, that we've had in before.

Jane said that Barb DePerto may need to get her nominating committee together again to search for a luncheon program chair. Barb Sweet said she would put a request for a program chair on our Facebook page.

Activity Group Chair - Dee Lewis

Cancelled activity. Jane received an email from one of our members who had signed up for an activity, arrived the night of the event, and no one was there. She subsequently learned that the event had been cancelled, but no one had called her to advise her of this. Dee was able to provide the background: the activity was put in the June Chatterbox because at time of publication (mid-

May), the activity coordinator was still doing the activity, which fell at the end of June. When the activity was cancelled, both the coordinator and Dee tried to access the activity signup list for June, but it had been archived already and was no longer accessible. Jane advised that she had been able to retrieve the signup list somehow, and only three members had signed up. In future, should this happen again, do check with web masters to see about accessing archived lists.

Budget for Coordinator Appreciation. Dee - we have 29 activity coordinators and 4 other coordinators for pot of gold, jewelry sales, etc., for a total of 33. Would like clarification on budget and intent for board party and coordinator gifts as this is changing for the new fiscal year. Judy advised that the new budget has \$250 for a Board party, when we get closer to the time that we would usually begin thinking about these things, the Board can decide how it would like to spend the money. Our most recent appreciation party this spring had a significant number of noshows, which resulted in wasted funds. Dee would prefer that the board and the coordinators be separated in terms of recognition. Her new activity budget is only about \$75 now, which is a little low in terms of gifts for coordinators. Ideas for recognition other than gifts were shared, as we're projecting a loss for the coming fiscal year and need to find places to reduce expenses without raising dues. It was decided to table this discussion for a few months until more is known about our 2025-26 financial situation. Recognition is typically done in the spring. Perhaps in January we can bring this topic back under Old Business for discussion and resolution.

Casual Mah Jongg. We need to move the day of the month casual mah jongg is played to the first Monday of the month. Dee made a motion to move the date; seconded by Claudia; no objections from the Board; motion passed.

Special Events Chair - Maria Greco

- Does anyone know Sheila Harris? She signed up for the cruise through Vacations to Go.
 We have a member named Susan Harris, but not a Shelia. I can call Susan to see if she goes by Sheila perhaps, but I wanted to ask here first.
- We have 39 signed up for the cruise in total; 26 members, 12 guests, and then Sheila, member status TBD. I've put together a booklet for everyone that will be coming out soon. Look on our website for links for the cruise; there's a link for discounted limo service (18% disc). Another link is for supplies for gamers. We do need game sets so let me know if you can bring anything.
- Each cabin is going to get 4 credits. Wine, champagne, fruit platter.
- Hours for gaming will be posted: Nov 8th 1pm-4pm; Nov 9th 1:30pm-8pm; Nov 10th, 11th and 12th 9am -8:00pm
- Do we want the staff to provide, in the gaming room, beverages and Danish/cookies all day for \$2.50 per person? The Board decided that wasn't really necessary as folks could go find food elsewhere on the ship and bring it into the game room.
- Dinner seating is on level 4, reserved. We're seated in the early dinner seating. There are people who don't want to be in the early seating, so they will be taken out of that group and will make their own reservations and won't be allowed back in the group.
- Everybody will take pictures and send the best ones back to Claudia!
