### <u>Treasurer – Judy Moore</u>

- Checking Balance \$11,931.59 Of this, about \$1800 is going to be paid very soon for the November luncheon. This is our revenue-generating season as memberships are renewing. After this, we have a lot of expenses that we're going to be paying.
- Savings Balance \$1,290 In savings is also about \$600 for the Mixer and the Mingler
- Balance CD \$8,630.47 This renews in January.
- The Candlelight Concert has been paid for, and our profit on this was \$42.51.
- Yesterday taxes were filed, and the IRS shows that our filings for the last three years are pending. I have to call and find out why they are pending, but they are filed, I have paper copies. As long as we keep our deposits for the fiscal year under \$50,000, we're still a nonprofit.

Casual MJ is designed for beginners and less experienced players who are still more thoughtful in their approach.
